


The complex will have built-in rental assistance, Qualified Residents pay 30% of their income for Housing Expense – Rental Assistance will pay the rest.



- 42" wide doors throughout apartment
- Hardwood and ceramic tile floors for ease of living
- Custom horizontal sliding energy efficient windows for easy opening
- Linen closets with slide out shelving
- Accessible light and thermostat controls
- Additional electric outlets in bedrooms

Kitchens with:

- Accessible kitchen cabinets with roll under access, slide out shelving and Lazy Susan setup
- Easy access side by side accessible refrigerator / freezer with automatic ice maker
- Front control range / oven
- Dishwasher
- Countertop Microwave

Bathrooms with:

- Accessible transfers shower units and some roll in shower units
- Accessible mirrors
- Additional grab bars

Medical Center. The development partnership has put the needs of those living with MS first. Together, this group will offer the residents at the complex wonderful benefits. The National MS Society will provide a multitude of programming opportunities directly at Kershaw Commons including:

- Recreational and Social Programs such as Tai Chi and Yoga
- Ongoing Periodic Lectures on MS Topics
- Outreach, Information and Referral to MS Medical or Service Specialists
- MS-specific Self Help Groups
- Employment Related Programs
- Care Management Service Assistance
- Caregiver Lectures for Family and Friends
- Equipment Assistance Purchase Stipends
- Coordination of Resident Use of the Linda E. Cardinale Multiple Sclerosis Center at CentraState Medical Center, less than 1 mile from Kershaw Commons

VNA, one of New Jersey's leading providers of in-home care services. To help coordinate care needs at Kershaw Commons, VNA will provide an interdisciplinary team of nursing and therapy professionals specially certified in the care of Multiple Sclerosis. This MS Specialty Team will be available by contract with interested residents of Kershaw Commons. ready to coordinate and provide comprehensive MS related services. The care coordinated by the MS Specialty Team is available separate and additional to the residential costs of these independent living apartments. Residents will pay for necessary services through a number of possible sources, including Medicaid, Medicare, private insurance, the State's PASP program or private pay.

National Multiple Sclerosis Society New Jersey Metro Chapter The National MS Society will be there for you! The New Jersey Metro Chapter has dedicated a **PROFESSIONAL SERVICES COORDINATOR** to help residents with their MS related questions and

planning. While Kershaw Commons does not directly provide home care services, the MS Society will be there to help you arrange your care plan. The National MS Society has strong links with those who help people with MS, and they will put those links to work for you — so you can get the care providers you may need. With expertise in MS and links to resources about Medicaid funding and the State's PASP program, the MS Society will help you make the right connections so you can get the assistance you need.



The National Multiple Sclerosis Society Difference





CentraState's MS Center* is located less then a mile away from Kershaw Common in a new ambulatory campus on the hospital grounds. The MS Center provides comprehensive, high-quality care specifically for patients with multiple sclerosis. The MS Center team is led by neurologists who specialize in MS, and is supported by a nurse coordinator, occupational and physical therapists, and speech and language pathologists. At the MS Center, other support comes from nutritionists, social workers, equipment vendors, and home care companies to assist in coordinating care, as well as psychotherapists for counseling. The Center also has a pharmacy, café and durable medical equipment on site.

Along side the MS Center is the state-of-the-art **Multiple Sclerosis Wellness Program**. This program is the first of its kind on the East Coast. Designed to address the physical and psychological issues associated with MS, this life-affirming program helps strengthen mind and body through:



EDUCATION: Learn about best nutrition practices for thosewith MS, how to manage stress and deal with continence issues, and how to avoid depression.

AQUATICS: A cool-water pool, buoys and other water resistance tools are provided to help patients build strength and improve balance. The program also offers non-certification scuba classes, which help patients improve their balance, while having fun!

EXERCISE: Group classes improve movement and increase flexibility through various seated exercises, weightlifting, strength and conditioning, T'ai Chi, and Pilates techniques.

Results of the comprehensive wellness program show that it has increased mobility and cognitive function, decreased the resistance to exercise and reduced fatigue.


